Dear State Party Leader,

We are rapidly approaching the time to begin the 2008-2009 reorganization process.

**Article VIII, Section C, of the Bylaws of the Democratic Party of the State of Washington**, referring to **County Central Committees**, states that

“Its organizational meeting shall take place in December or January following each state general election held in even-numbered years. At the organizational meeting, the committee shall elect a chair, a vice chair, a state committeewoman, a state committeeman and any representatives it is authorized to send to other Party organizations.”

This language is repeated in Article IX, Section C, of the same bylaws in regards to **Legislative District Organizations**.

This letter will provide you with the information you need to begin planning for your local reorganization meeting.

**Time and Date**

The State Democratic Party advises you to proceed on this time table and to conduct your reorganization meeting as you have historically done so.

Your County or Legislative District Reorganization Meeting must take place prior to the January 23<sup>rd</sup>-24<sup>th</sup>, 2009 Reorganization Meeting of the Washington State Democratic Party. It is crucial that you make sure that your list of newly elected party officers and WSDCC committee members is received by the state party prior to this meeting.

**Proposed Rules**

1. Sign-in is required at check-in.
2. Eligible voters shall be limited to PCOs elected during the August 19<sup>th</sup>, 2008 Primary.
  - A. Eligible voters will be issued ballots.
  - B. A 50% + 1 majority of members present and voting is necessary to approve any vote unless otherwise noted.
3. The meeting shall be called to order by the Temporary Chair.
  - A. The Temporary Chair shall preside until the election of the new Chair.
4. The Temporary Chair shall review the Proposed Rules with the Body.
5. The Body shall vote to approve the meeting Rules.
6. Election of officers shall proceed in the following order:
  - A. Chair
  - B. Vice Chair
  - C. State Committee Man
  - D. State Committee Woman
  - E. Treasurer
  - F. Secretary
  - G. *Other elected party representatives if necessary*
7. Process for nominating and electing all positions shall include the following:
  - A. Call for nominations
  - B. Close nominations
  - C. One minute nomination speech for all candidates
    - i. Order of speeches determined by order of nominations.
  - D. One minute seconding speech for all candidates.
  - E. Speakers for all races may be PCOs, candidates, or Democratic residents of the County or Legislative District.
8. Elections shall be conducted by written ballot.
  - A. In order to assure accuracy eligible voters shall sign their ballots. An unsigned ballot will be considered void.
