



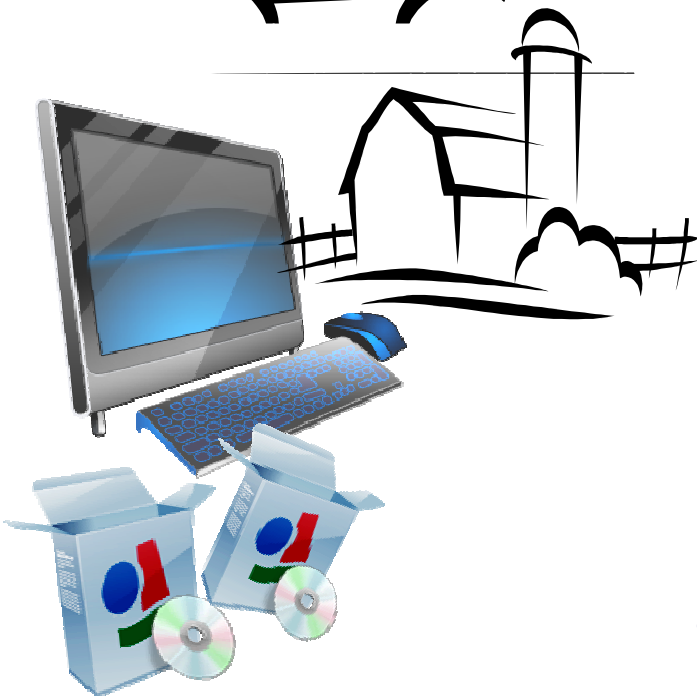

## **Proposed Rules for 2010 King County Convention**

1. The King County Convention shall be held on Saturday, April 10, 2010, commencing at 10:00 am, at the IAM Hall, 9125 15th Place South, Seattle, Washington 98108.
2. To vote at the King County Convention, an individual must be a resident, registered voter in King County and sign a registration sheet stating that he/she is a Democrat, and agrees to public display of her/his attendance at the meeting. Individuals who are not qualified to register to vote because of residence or citizenship shall be allowed to participate in the platform discussion, but may not vote on platform planks or resolutions.
3. There will be a suggested donation for all participants to the County Convention of \$30.00 at the door - The donation includes a box lunch. Donation shall not be a condition of participation or election.
4. The King County Chair or the Chair's designee shall serve as the Temporary Chair of the convention.
5. The Co-Chairs of the Credentials Committee shall present the report of the Credentials Committee which shall include: The total number of eligible registered voters in attendance at the Convention. The sign-in tables close after the report is presented and approved.
6. The Chair of the Rules Committee shall present the report of the Rules Committee.
7. Any voting member of the Convention may nominate themselves or be nominated by another voting member for the position of Permanent Chair. Nominations, seconding speeches and speeches by the candidate on his or her own behalf shall not total more than three (3) minutes per nominee. A majority is required to elect. If no person has a majority, the candidate receiving the least votes is dropped and balloting shall be repeated using the remaining names. This procedure shall be repeated until a candidate receives a majority.
8. The Permanent Chair shall appoint a Secretary, Sergeant-at-Arms, Parliamentarian, and Timekeeper.
9. The motion "to table" shall be out of order at all times.
10. Debate shall alternate pro and con, limited to two speakers for and two speakers against any motion, each speaker to speak no more than one minute.

11. A quorum shall consist of 30% of the number eligible to vote as shown on the credentials report, as most recently amended. A quorum call will be out of order until the platform is adopted.
12. The Platform and Resolutions Committee began with the 2008 King County Democratic Platform and revised it to reflect changes in the political landscape since then. The proposed platform was posted online and mailed out with the "Call to the Convention."

Amendments must be submitted to the presiding chair in writing, with 25 signatures from among those Democrats present, before the beginning of the platform portion of the agenda. A second copy should be given to the convention secretary, with a header that includes the section name and page number.

Motions to delete an item do not require signatures. Each Platform section will be considered in order. The chair will call for flags, representing a motion to delete, and a show of 25 voting credentials will sustain the flag for deletion. The chair will also announce any qualified proposed amendments. The un-flagged portions of the Platform will be adopted without the flagged items, and then all flagged items and proposed amendments will be considered section by section, in order. Minor editorial corrections may be submitted to the Platform and Resolutions Committee Chair at the table at the front of the hall; technical/grammatical corrections may be made at the Platform and Resolutions Committee Chair's discretion.

To be considered, Resolutions must be submitted to the Platform and Resolutions Committee Chair in electronic form by the close of business, Friday, April 2, 2010 - one week before the April 10th King County Democratic Convention, so the committee can consider and revise them. Please refer to the King County or Washington State Democratic websites for the preferred format.

Resolutions should be limited to one page and should contain the name and email address of the author.

Resolutions should not duplicate issues contained in the draft platform, but should be issues of immediate concern to Democrats. Approved resolutions will be prioritized and up to ten (10) will be submitted to the Convention. The Top Ten (10) Resolutions will be considered automatically in order and will be displayed on screen. Resolutions can be amended only striking a section or amending a "resolved" clause.

Otherwise, Resolutions will be voted upon "as-is." A Platform section or Resolution comes as a recommendation from the committee - they do not require a second.

13. Voting will occur by raising of convention credentials by attendees and recorded in the official meeting minutes.

14. Proxy voting shall not be allowed.

15. All possible efforts shall be made to insure maximum participation of ethnic minorities, women, youth, persons over 65 years of age, lesbians and gays, Labor, persons with a high school education or less, disabled, and persons of economic disadvantage.

16. Robert's Rules of Order, Newly Revised, shall prevail in other matters not specifically covered herein.
